#### **IMPORTANT**

Your course proposal should contain a brief outline of the aim, main contents, learning objectives, and teaching methods. Please state the proposed level (BA or MA). Applications that do not contain a course proposal will not be taken into consideration. Note that the teaching will take place on-site at Aarhus University.

#### Salary

The salary offered is 8075 EURO. We also pay for one return ticket on economy class. Your salary will be subject to taxation in Denmark, and the tax rate will be around 25%. Double taxation agreements may have an influence on the total taxation of your income in Denmark when declared at home.

#### Teaching periods for 2025

You can choose to run your course in Term 1: 2 July - 18 July 2025

or

Term 2: 23 July - 8 August 2025

You are expected to teach all weekdays from 9-13, start and end date included. Class size ranges between 20 and 40 students.

Besides teaching, we expect you to assess the written exam and two retakes.
